RE: Office of the Mayor Executive Order 2020-007
Curfew
Special Order #20-031

On June 1, 2020 in response to the ongoing civil unrest within Louisville Metro, Mayor Greg Fischer issued Executive Order 2020-007 (Attached) which includes:

- An extension of a second state of emergency (in addition to the Covid-19 Pandemic)
- The extended State of emergency commences at 9:00PM tonight, June 1, 2020 and each night until 6:30AM June 8.
- A curfew has been imposed.
- All individuals shall return to their residences and remain off of all common areas, including but not limited to streets, parks, right of ways, and other public spaces by 9:00 PM until 6:30 AM the following morning.
- This Order shall not apply to individuals commuting to and from their respective employment. This restriction does not impede any business from engaging in their regular and typical shifts, schedule or manner of operations.
- This Order shall not apply to individuals who are commuting to a house of worship for services.
- This Order shall not apply to individuals involved in any action medically necessary to protect a friend or family member.
- This curfew shall remain in effect until Monday morning June 8, 2020 at 6:30AM at which time this Order will be re-evaluated.

Appropriate Charges If Applicable:

-CURFEW VIOLATIONS – ONLY AFTER 9:00PM and before 6:30AM

LMPD officers who observe individuals in violation of this order will first inform the individual of the existence of said order and try to gain voluntary compliance.

If an individual refuses to comply with the officer's persuasion and direct orders do not work, officers may arrest those continuing to refuse to comply for violating this order.

If you are hand-writing the citation, your KRS will be 39A.190

In addition to articulating the facts of your specific engagement with an individual, your narrative must include:

This individual violated Executive Order No. 2020-007, KRS 39A.190 when he/she refused to comply with the listed curfew order after officer gave the individual notice that he/she was in violation of the order and was granted the opportunity to comply.

-FAILURE TO DISPERSE

On your citation, you will use:
UOR Code 02637 Failure to Disperse

For your reference:

KRS Section 525.160 Failure to Disperse

A person is guilty of failure to disperse if he participates with two (2) or more persons in a course of disorderly conduct likely to cause substantial harm or serious inconvenience, annoyance or alarm, and intentionally refuses to disperse when ordered to do so by a peace officer or other public servant engaged in executing or enforcing the law.

A copy of the Mayor's Executive Order is attached to this Special Order.

All members having computer access are responsible for reading, understanding, and acknowledging receipt of this Special Order, using the PowerDMS Document Management System. Members without computer access will continue to sign an accountability roster, as they have in the past.

All commanding officers will ensure that their personnel are made aware of this information.

EXECUTIVE ORDER

NO. 2020-007

June 1, 2020

CONTINUATION OF SECOND STATE OF EMERGENCY DUE TO CIVIL UNREST

WHEREAS, I have previously issued Executive Orders 2020-001, 2020-002, 2020-004, and 2020-005 that declared a state of emergency due to the novel coronavirus (COVID-19) pandemic that expires on June 30, 2020 and also provides for numerous measures to prepare and respond to the needs of the Louisville Metro community during this emergency; and

WHEREAS, recent events over the last four nights related to protests which have resulted in widespread property damage, looting and other unlawful conduct in Louisville Metro;

WHEREAS, I issued Executive Order 2020-006 that instituted a curfew from 9:00 pm to 6:30 am for the past weekend and recent events necessitate that the curfew be extended;

WHEREAS, KRS 39A.180 vests the Chief Executive Officer of a consolidated local government with the authority to issue executive orders necessary for disaster and emergency response purposes and to supplement the carrying out of the provisions of KRS Chapters 39A and 39B;

NOW, THEREFORE, I, Greg Fischer, as Mayor of Louisville/Jefferson County Metro Government and, pursuant to KRS Chapters 39A and 39B of the Kentucky Revised Statutes, HEREBY CONTINUE THE DECLARATION OF EMERGENCY within Louisville Metro related to the well-being our citizens and businesses. To that end, I hereby ORDER AND DIRECT THE FOLLOWING:


1. That the curfew imposed in Executive Order 2020-006 shall be extended until 6:30 am Monday, June 8, 2020. The curfew will commence at 9:00 pm tonight and be imposed each night at 9:00 pm until 6:30 am each following morning. This curfew shall be in effect for all of Louisville Metro and all individuals should return to their residences and remain off of all common areas, including but not limited to streets, parks, right of ways, and other public spaces by 9:00 pm until 6:30 am the following morning; and
2. This Order shall not apply to the following individuals:

a. Individuals commuting to and from their employment and engaging in their respective employment. This restriction does not impede any business from engaging in their regular and typical shifts, schedule or manner of operations; and

b. Individuals commuting to and from a house of worship to attend services; and

c. Individuals taking action to provide medical care that is necessary to protect an individual who needs medical care;

3. This curfew shall remain in effect until Monday morning June 8, 2020 at 6:30 am at which time this Order will be re-evaluated.
